RULES AND REGULATIONS

IMPORTANT READ CAREFULLY AND SIGN AT THE BOTTOM

APPLICATION DEADLINE MARCH 15, 2010

CONDITIONS :

Upon arrival, confirm number of stalls needed with the Director of Racing. Photo identification badges or passes are issued only the persons listed as owners, and are not transferable, and said Photo ID badges must be worn at all times. All horsemen, owners, trainers and grooms must be licensed by the Ohio Racing Commission, and the United States Trotting Association. Person not actively on a payroll will be ejected, even if they are licensed, as per Ohio Racing Commission Rule #3769-5-01. Upon entering the stable area, all persons are required to show their ID to the Gate Security Guard.

Sections 3769-5-34(D) and 3769-15-32(C) of the Ohio Rules of Racing reads as follows:

No horse shall be admitted to any race track facility in Ohio without having had a negative official test for equine infectious anemia with the past twelve months.

Any horse entering Ohio race track facilities from out of state must have had an official negative equine infectious anemia test within the past one hundred and eighty days. It is the trainers responsibility to see that each horse had the proper EIA papers.

By signing this it is hereby agreed that Scioto Downs shall **NOT** be liable for, and that the owner and/or lessees of the horse will indemnify and hold harmless Scioto Downs against all responsibility, liability or claim of injury or damage to any person, horse or other property of the undersigned, or of any other person, or his or their agents, employees or associates, caused by the horse, or the agent of the employees of the undersigned, or by any other person, including employees, agents of Scioto Downs, whether by negligence or otherwise, on the premises of Scioto Downs.

Scioto Downs reserves the right to cancel any stall privileges at any time. In addition, Scioto Downs reserves the right to refuse admission to or to exclude any person or horse or both and further reserve the right to remove any person, equipment, or horse from said premises at any time. Any costs incurred in removing equipment and/or horses from said premises shall be charged to and paid by the undersigned.

NO DOGS WILL BE ALLOWED IN THE BARN OR STABLE AREA AT ANY TIME. RULES OF THE STATE FIRE MARSHALL PROHIBIT COOKING AND ANY USE OF ELECTRICAL APPLIANCES IN THE BARN OR STABLE AREA, TACK OR DORMITORY ROOMS.

The main five-eighths mile track will be closed daily at 1:00 P.M. to prepare the track for the nightly racing program and it will be closed all day Sunday. The three-eighths mile track in the stable area is open at all times. Rules of the Ohio State Racing Commission to govern in all cases.
